Commercial facility reinspection due to changes or upgrades	\$110 first assembly, \$15 each additional, billed on UB account or on work order if applicable
New commercial facility	T&M to be billed to work order
Late fee/Doorhangers	\$20 billed on UB account
Backflow testing program	\$19 billed on UB account
Noncompliance with annual testing requirements	\$40 tester's fee per assembly, \$55 administrative fee billed on UB account
Noncompliance with assembly installation requirements	T & M for contracted installation and testing, \$150 administrative fee, billed on UB account

1" Meter Rental	\$750 deposit (\$30 testing fee, \$95 billing fee and water usage will be deducted from the deposit. If after fees are deducted, water use exceeds the deposit amount, the balance due will be billed.)

J. Fire Flow Guarantees

Out of service area fire flow guarantees for residential and commercial properties shall be on a case by case basis and shall be charged at gpm requested x 1.5. In service area (but non customer) fire flow guarantees for residential and commercial properties shall be on a case by case basis and shall be charged at gpm requested x 1.0.

If payment is insufficient, meter will be relocked, accrue another unlock fee, as well as insufficient funds fee and will not be unlocked until account is paid in full by cash, cashier's check, or money order.
